

Onsite Shredding Service

Vyta's onsite shredding service, DiskShred, is the UK and Europe's most reliable, cost-effective solution for businesses and organisations that require the complete destruction of data-bearing devices.

Vyta has a fleet of state-of-the-art GPS-tracked shredding trucks operating across the UK and EU, able to shred large volumes of hard drives, SSDs, USBs, CDs and more down to debris as small as 6mm. Once devices are shredded, we responsibly recycle the debris, recovering valuable materials and minimising environmental impact.


